Kurt Special Resolutions and proposed Bylaw amendments

By Laws Part 2 (4) - Membership "A person may apply to the Directors for membership in the Society and upon acceptance by the Directors and upon payment of dues as shall be from time to time set by the Society, that person shall be a member".

Amendment

- -All Tub Pilots that have raced in the past year are members.
- -Annual fee of \$5 (Tub Pilots excluded)
- -Member must perform 4 hours of Volunteer service annually to the LNBS

Amendment Passed

Part 2 (7)-Membership "A person shall cease to be a member of the Society a) by delivery his resignation in writing to the Society of the Society or by mailing or delivering it to the address of the Society, or b) on his death or in the case of a corporation on dissolution, or

Amendment - c) All members must demonstrate Spirit and Intent, which includes, but is not limited to; Attitude, behaviour, racing etiquette, or language. Spirit and Intent may be determined by the LNBS members whose ruling will be final and NOT subject to review and will result in the member being not in good standing if found in violation. Motion at a meeting, 14 days notice of a meeting vote.

Amendment Passed with changes

Part 3 (10)-Meeting of Members "General meetings of the Society shall be held at such time and place, in accordance with the Societies Act, as the Directors decide."

Amendment - "but must give the members a minimum 7 days' notice, 14 days if votes are to be cast."

Amendment

(3), to include members from out of town, or unable to physically attend, a provision which enables participation via teleconference will be provided.

Part 4 (22) (3) Proceedings at General Meetings. "Voting by Proxy is not permitted."

Amendment -Allow Proxy voting by signed hand written letter or email from members account 7 days prior to each general meeting.

Part 5 (25) (3)-Directors and Officers "All past Commodores in good standing shall be members of the Executive."

Amendment

- -Create a new "Class" called "Executive Committee".
- -The Executive Committee will include: Current Commodore, past Commodores & Directors in good standing (No Annual fee required).
- -Vote on everything but financial

Rules

Proposed Changes

Rule change suggestions to helmet, safety gear, weight restriction. Feedback to keep the weight restriction in place.

Helmets need to be tested and due diligence done. Safety is the first consideration. Discussion about helmet, provide options.

Nathan suggested no paddler and bailer, add a flare.

Amendment - Approve White Water Class 3 or higher helmets that meet, at minimum, the CE EN 1385 Standard.

Amendment Passed

CE EN 1385 CLASS I/IV – Helmets for canoeing and white-water sports

There are six major requirements a helmet, for this use, needs to surpass to be certified:

- 1. Field of vision (Making sure the helmet design does not interfere with the user's field of vision)
- 2. Extent of coverage (Making sure the helmet covers all necessary parts of the head)
- 3. Shock absorbing capacity (The most important is the shock absorbing capacity of the helmet. This is tested in a specialized instrument where the helmet is dropped with the speed of 2,5m/s onto a solid metal anvil with a 4 kg metal head inside. Inside the metal head there's an accelerometer that measures the forces within the impact.

The Helmet must float after it has been submerged for 4 hours. Each helmet is tested on several areas (crown, side, rear & front). The peak acceleration must not exceed 250G for any of the impacts.)

- 4. Retention system performance (This test covers the strength of the retention system (webbing), as well as its effectiveness, i.e. the webbings ability to keep the helmet securely positioned on the head.)
- 5. Buoyancy (After being submerged for at least 4 hours, the helmet must float to the surface.)
- 6. Durability (After all these tests the helmet should not show any damage that would cause any additional damage to the wearer.)

ASTM F1952 and ASTM F2032 - Helmets for Downhill Mountain Bike Racing

Comparison of Impact Velocities

The impact velocity is the speed of the drop apparatus just before the helmet strikes the anvil. The numbers are in meters per second, translating to drop heights of about:

The hemispheric anvil is grapefruit-size, with a 48mm/1.9" radius. The curbstone anvil is a slightly rounded 90 degree bend, with the helmet dropped vertically onto the bend.

Comparison of Test Lines

The test line is drawn on a helmet to mark the lowest limit where a lab technician can impact the helmet. The distances are above the reference plane, a line drawn around the headform at the ear level. Lower numbers are better, indicating that the test line is closer to the reference plane and the helmet must have more coverage.
